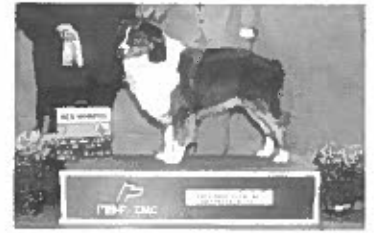

Boarding Agreement

This is a contract between Taylor Made Kennels and the pet owner whose signature appears below (hereinafter called "Owner").

1. Taylor Made Kennels hereinafter referred to as "TMK", agrees to exercise due and reasonable care to keep its premises sanitary and properly enclosed.
2. TMK agrees to exercise reasonable care for the pet delivered by the Owner to TMK for boarding. TMK does not assume and shall not be held responsible for any liability with respect the animal listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this animal, or any damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named animal during the term of this contract, whether this animal be on the premises of TMK or not, and the owner of said animal agrees hereby to be and is solely responsible for any and all acts of behavior of said animal at any time within the term and time of the contract. The responsibility and/or liability of TMK, in no event shall exceed the sum of Two Hundred Dollars (\$200.00) and the undersigned agrees to limit the responsibility to Two Hundred Dollars (\$200.00) for any and all damages sustained or suffered by reason of the boarding of this animal and said TMK to the sum of Two Hundred Dollars (\$200.00) and no more, and agrees not to claim any damages against said TMK of any nature whatsoever, either by way of contract, equity, negligence or otherwise, in excess of said sum. It is expressly agreed by Owner and TMK that TMK's liability shall in no event exceed the lesser of the current value of the dog of the same species or the sum of \$200.00 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of TMK.
3. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of TMK.
4. Owner further agrees that the pet shall not leave TMK until all charges are paid to TMK by Owner.
5. The owner of the within named animal specifically represents that he is the sole owner of said animal and that there is not now any lien or mortgage against said animal.
6. The TMK shall have, and is hereby granted, a lien on the animal for any and all unpaid boarding and/or other charges resulting from the boarding of said animal with TMK.
7. If the animal becomes ill, the owner shall be notified at once, collect, if possible, or such attempt shall be made to so notify the owner, and if owner does not immediately inform TMK regarding measures to be taken or if the state of the animal's health requires quick action, the right to call a veterinarian or to administer medicine or to give advisable attention within the discretion shall be taken for granted by TMK, and such expenses being reasonable in amount shall be promptly paid by owner.
8. This Contract contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, and assigns of the owner of the within named animal.
9. Any controversy or claim arising out of or relating to this contract shall be settled by arbitration in accordance with the rules of the American Arbitration Association. The arbitrator shall, as part of his award, determine an award to the prevailing part of the cost of such arbitration reasonable attorney's fees of the prevailing party.
10. TMK is not responsible for lost or damaged toys, bedding or any misc. items. Please bring only blankets or mats, no beds with stuffing.

I further understand and agree that any illness that my dog(s) develop(s) while visiting Taylor Made Kennels will be treated as deemed best by staff of Taylor Made Kennels and in their sole discretion, and that I assume full financial responsibility for any and all expenses involved.

I certify that I have read and understand the payment terms, rules and agreement. I agree to abide by the rules and accept all the terms, conditions, and statements of this agreement.

I further understand and agree that my dog(s) may be injured or may cause injury to another dog(s). While every attempt to maintain a safe atmosphere is taken, dogs will be dogs. In the event of an injury to your pet, we will take the necessary steps to care for your loved one. All parents must assume financial responsibility. This also applies to instances in which your pet inflicts an injury to another dog(s).

PHOTOGRAPHY: I give Taylor Made Kennels the right to use photographs of my dog(s) as often as desired. I waive right of approval and release Taylor Made Kennels from all claims which I may have on account of use of publication of any photographs.
